AMENDMENT TO ARTICLE VI - OFFICERS

Article VI - Officers of the original Articles of Incorporation shall be amended to read as follows:

ARTICLE VI - OFFICERS

The affairs of this corporation shall be managed under the direction of the Board of Directors by the following officers: a President, one or more Vice Presidents, a Secretary and Treasurer. Vacancies in the offices of the President, Vice Presidents, Secretary or Treasurer shall be filled by the Board of Directors until the next annual meeting. Vacancies in the Board of Directors shall be filled until the next annual meeting by the remaining directors.
