ARTICLE III.

The corporation shall be non-stock, and non-profit and no dividends or pecuniary profits shall be declared to the members thereof. The general nature or the object of the corporation shall be to establish and maintain a public school band program, and to establish, maintain and conduct a school for the musical instruction of school children in said City of Auburndale, Polk County, Florida; and to that end may adopt and establish By Laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with law and not inconsistent with these Articles of Incorporation; and to take, manage, hold, impose and dispose of the property, real and personal, of said corporation.

Notwithstanding the forgoing, said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, of corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
