## ARTICLES OF AMENDMENT TO THE SECOND REVISED CHARTER OF INCORPORATION OF FLORIDA BAPTIST SCHOOLS, INC.

Document number 703957

Pursuant to the provisions of section 617.1006, Florida Statutes this *Florida Not For Prof.*Corporation adopts the following amendments to its Second Revised Charter of Incorporation, fill with the office of the Secretary of State of the State of Florida on December 9, 1994:

#### AMENDMENT ONE - NEW CORPORATE NAME

ARTICLE I of the Second Revised Charter of Incorporation is hereby deleted and replaced by the following:

#### ARTICLE I - NAME AND LOCATION

The name of this corporation is **EMMAUS BAPTIST COLLEGE**, **INC.**, whose address is 706 Dew Bloom Road, Brandon, Hillsborough County, Florida 33511, or at such other addresses as may be designated by the Trustees of this corporation with the approval of the sponsoring churches which make up the membership of this corporation.

#### AMENDMENT TWO - RESTATED PURPOSE

ARTICLE II of the Second Revised Charter of Incorporation is hereby deleted and replaced by the following:

#### ARTICLE II - PURPOSE, NATURE, AND OBJECTIVES

The purpose, nature and general objectives of this corporation are:

- 1. To promote, administer and financially undergird EMMAUS BAPTIST COLLEGE and such other institutions for Christian education it may choose to operate as permitted by this charter; by the application of recognized academic standards in a manner consistent with the historic faith of Landmark Missionary Baptist Churches.
- 2. All actions and functions of this corporation shall be exclusively for the purpose of promoting Christian education. This corporation shall never engage in any activity for profit or for any political purpose.

#### APPLICATION AND ADOPTION OF AMENDMENTS

Unless otherwise specifically stated in these Articles of Amendment, all provisions of the existing Second Revised Charter of Incorporation remain in full force and effect. The date of adoption of these amendments was <u>April 22, 2007</u>, to be effective upon the filing of these Articles with the office of the Secretary of State of the State of Florida. The amendments were

adopted by the unanimous vote of the sponsoring churches which constitute the membership of this corporation. This vote was sufficient for approval.
