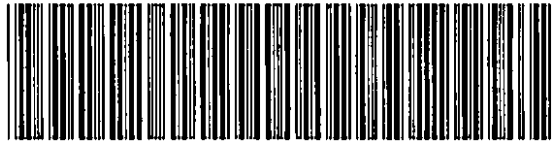

**Articles of Amendment
to the Articles of Incorporation of
FEDERATION OF MANUFACTURED HOME OWNERS OF FLORIDA, INC.**

Pursuant to the provisions of Article XIII of the Articles of Incorporation, the Corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation.

1. ARTICLE I of the Articles of Incorporation of the **FEDERATION OF MANUFACTURED HOME OWNERS OF FLORIDA, INC.**, is hereby amended as follows:

ARTICLE I

The principal address of the corporation is: 1101 Belcher Road S., Suite B,
LARGO, FL 33771.

2. ARTICLE X of the Articles of Incorporation of the **FEDERATION OF MANUFACTURED HOME OWNERS OF FLORIDA, INC.**, is hereby amended as follows:

ARTICLE X

State Assembly:

- A. The State Assembly shall be a general membership meeting. There shall be at least one (1) meeting every two years, as governed by the Bylaws.
- B. The voting body shall be delegates each representing approximately the same number of members. They shall be elected or appointed as provided in the Bylaws.
- C. The delegates shall represent the general membership in all matters pertaining to the Corporation, including but not limited to, the election of State officers and voting on changes in the Bylaws or Articles of Incorporation.
2. This Amendment was adopted on **December 5, 2019**.
3. The Amendment was submitted by resolution to the delegates who represent the members at the State Assembly and was approved by more than two thirds of the delegates as required by the Articles of Incorporation and the Bylaws of the Corporation.
4. All other portions of the Articles of Incorporation shall remain the same.
