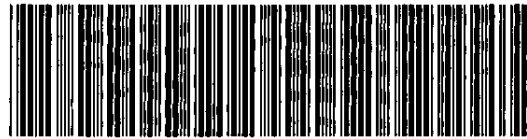

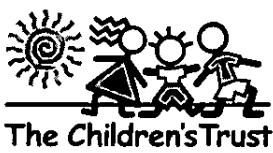

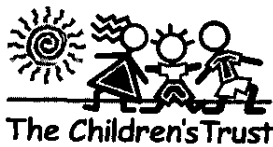

- I. CALL TO ORDER** The meeting was called to order at 2:15 p.m. by Dr. Robert Moore, President.
- II. READING OF MINUTES** A motion was made, seconded and passed unanimously to accept the minutes of the January 10, 2011 meeting as received.
- III. TREASURER'S REPORT** Mr. Gerald Moore, Treasurer, reviewed the financial status, moved that all monies owed be paid promptly and that the CEO be named the Trustee of a BACC transition account to be established to handle financial business necessary after the official date of closing June 30, 2011. Motion was seconded and passed unanimously.
- IV. CEO/EXECUTIVE DIRECTOR'S REPORT** Ms. Carolyn Jenkins-Jaeger presented the following:
- The BACC Closing Plan was reviewed and copies of correspondence to our partners and funding entities were provided. Our financial audit by Pedro de Armas, CPA, Verdeja/De Armas, Inc., will be completed as soon after program closing as possible and a BACC Transition Account will be established. From this account, the CEO will pay (via 1099s) any employees to complete unfinished business after June 30, 2011. All remaining assets will be donated to the SED Children's Fund, Inc. This activity will be in consultation with the auditor and Board Treasurer, Gerald Moore.

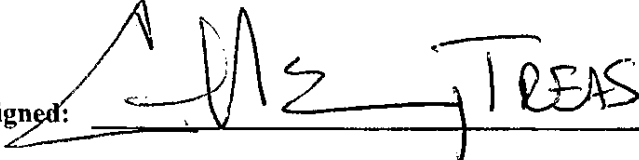
