The meeting was called to order by Mr. Barfield and Mr. Baugh gave the invocation. Members present said allegiance to the flag.

Mrs. Bryant read the minutes from the last meeting. Mr. Baugh made a motion we accept them as read and Mr. Adams seconded the motion. The motion was approved. Mrs. Bailey read the financial report. Mrs. Purvis made a motion that we accept it as read and Mrs. Lovell seconded the motion. The motion was approved.

#### **Old Business:**

- Mr. Adams made a motion that we keep the 2015 budget the same as year 2014. Mr. Barfield stated that we did
  that at the last meeting. Mr. Adams was absent.
- 2. Someone asked Mr. Barfield who could vote on the dissolution of the SCC, Inc. and he said he would read from the by-laws which he had with him this time.
- Mr. Barfield, chairman of the Board of Directors, read from the by-laws stating who could legally vote on the dissolution of the Seminole Community Center, Inc. Page 2, section 4, Sub. Paragraph 1 and 2, members rights and members in good standing.
- 4. Mr. Barfield stated that the dissolution of the Seminole Community Center has been going on for the last 3 or 4 years. He stated that we had a cookout at the Seminole park to which only about 30 people attended and a Christmas party last December to about 20 folks attended. The Board of Directors has sent out several letters trying to get people of the community to come take an interest to no avail.
- 5. Mr. Adams made a motion that we donate some of the assets to charities. A discussion followed. The following charities were decided upon: The Salvation Army, FT. Walton Beach FI., Sharing and Caring, Niceville, FI., Wounded Warriors Project, Jacksonville FI., Students for Life, Merrifield, Va., The Children's Advocacy Center, Niceville, FI., and the Relay for Life Cancer Center in Niceville, FI. We will donate \$1,000.00 to each. Mr. Baugh seconded the motion and the motion was approved. The rest of the assets will go to the county and hopefully they will be used in our community.
- 6. Mr. Adams made a motion that we vote on dissolution of the Seminole Community Center, Inc. and Mrs. Bailey seconded the motion. We voted to go ahead with the dissolution. The motion was approved.
- 7. Mr. Adams stated that we need to send a copy of the minutes to Amy Allen. Mr. Barfield stated we need to send the address and phone numbers of the Council on the Aging and the Church that use the building each week to Amy Allen.
