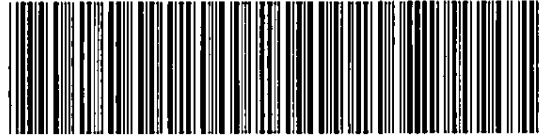

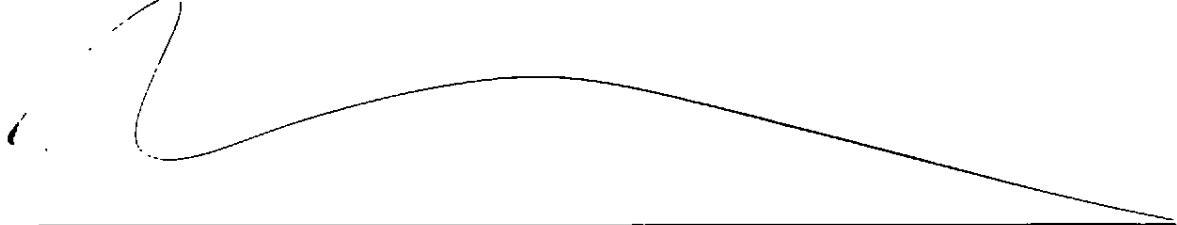

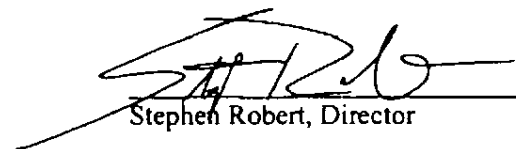

Pursuant to the provisions of Section 607.1001, 607.1003, and 607.1006, Florida Statutes, Florida Baptist Children's Homes, Inc., a Florida corporation (the "Company"), adopts the following Articles of Amendment to its Second Amended and Restated Articles of Incorporation:

FIRST: Article I of the Company's Second Amended and Restated Articles of Incorporation has been amended to read as follows:

The name of this corporation shall be One More Child, Inc. (the "Corporation").

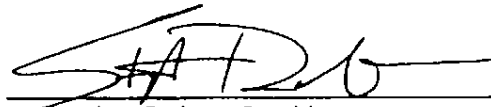
SECOND: The Company's Second Amended and Restated Articles of Incorporation were filed on April 20, 2016.
