**DEFAULT FINAL JUDGMENT**


THIS CAUSE having come on to be heard on July 21, 2017, upon the Plaintiff's Motion for Judicial Default, and the Court having heard argument and being otherwise duly advised in the premises, the Court hereby makes the following findings:

1. Mr. Jose Luis Pujol passed away on March 15, 2017 and is no longer a party in this matter. The Court hereby dismisses this claim as to Defendant Jose Luis Pujol.
2. Mr. Eladio Jose Armesto was served on June 2, 2017 and failed to file a responsive pleading to this claim.
3. Mr. Eladio Jose Armesto did not appear before the court on July 21, 2017

It is therefore ORDERED:

1. A default is entered herein against Defendant Eladio Jose Armesto for failure to file a responsive pleading herein. The claim of \$5,000 for the value of the stolen goods is hereby GRANTED.
2. The claim for injunctive relief is GRANTED: Mr. Eladio Jose Armesto can no longer represent (i) himself as a director or member of the National Journalist Association of Cuba in Exile in any capacity, and (ii) the English and Spanish entities are one and the same. The rightful directors and the only individuals with the authority to act on behalf of the National Journalist Association of Cuba in Exile are its Dean Salvador Romani Orue and those elected in 2017 as per the Association's documentation.
