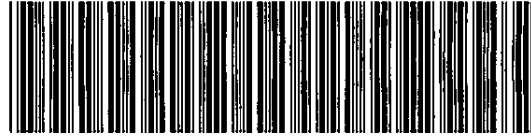





I, the undersigned GARY CHRIEN, certify that the following assertions are true:

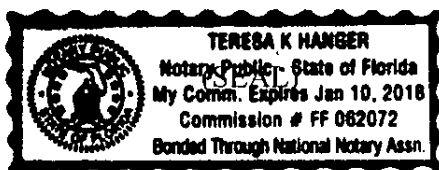
1. I am the President of St. Matthew Evangelical Lutheran Church, Inc., which is situated in Tampa, Florida.

6. The attached plan is a true copy of the plan which was approved by the Board of Directors and voters of said church.


