ARTICLE III

Church of God Latin American Missions, Inc. will only consist of one pastor, and it is established as a bilingual congregation consisting of both Americans and Latin-American members. Membership and officers will change from seven members to five, because we are no longer two congregations, but one.

ARTICLE XII

The property located at 1006 So. 50th St. has been sold effective February 11, 1998. There are no binding factors set forth to operate as the "Spanish Speaking Congregation" and the "English Speaking Congregation." Therefore, Membership Approval of Transactions as Real Property will be set forth as amended in its entirety to read as follows:

A 2/3-majority vote of the congregation and a majority vote of the Board of Trustees shall be required in order to sell, mortgage, etc.

ARTICLE XIII

The power to adopt, alter, amend or re-appeal by-laws shall be vested in the membership and the Board of Trustees as follows:

In order to adopt, alter, amend or re-appeal any or all by laws, such changes must be adopted by a 2/3-majority vote of the congregation and a majority vote of the Board of Trustees.
