ARTICLE 12- SPECIAL PROVISIONS

DELETE THE FOLLOWING SENTENCE ONLY: "Upon dissolution of the Corporation, the assets shall be distributed by the Board of Directors to educational institutions serving the needs of the Church as the Board of Directors may see fit."

ADD THE FOLLOWING IN ITS PLACE: " Upon the dissolution of the organization, none of its funds or assets shall be distributed to any director, officer, trustee, member or any other individual. The church board shall, after paying or making provision for the payment of all of the liabilities of the church, distribute funds and assets for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Any such funds or assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such religious purpose."
