FIRST

The name of this corporation shall be GULF GATE COMMUNITY ASSOCIATION, INC., Sarasota, FL 34231. Mailing address shall be 7350 S. Tamiami Trail #57 or such other location, as the Board of Directors shall designate.

SECOND

The purpose for which this Corporation is organized are to maintain, perpetuate and endeavor to increase the property values of Gulf Gate Subdivision, Sarasota, Flonda or any residential area which has been or in the future may be considered eligible for membership in the association and voted into same, create a Corporation under laws of the State of Flonda, not for profit, composed of real property owners and residents, in ordar that said individuats may coordinate their efforts toward maintaining and beautifying their particular tiving area, to buy own, hold, lease, sell, mortgage or otherwise convey, acquire or dispose of any and all types of real and personal property which may be necessary or appropriate for the foregoing uses, to establish rules and regulations for edmission, the foung of the amount of membership less if any, and to provide for the making and adoption of by-laws or other instruments; and to permit the appearance and testimony before public bodies including, but not limited to Sarasota County Commission, and vanous administrative units in all malters affecting the interests of the Corporation and its members, and if necessary, to take legal or administrative action to effectuate the purpose, to do all other things necessary whatsoever to carry out the adoressed outposes in an efficient and businessible manner.

THERD

The annual dues shall be such amount, d'any, as the membership may fix from time to time, by a majority vote of those present and voting at any meeting, registar or special. The fiscal year for the Corporation shall be the calendar year.

FOURTH

The term for which the Corporation is to exist shall be perpetual, unless otherwise duly dissolved, in accordance with these articles of incorporation, or by operation of Law

FIFTH
