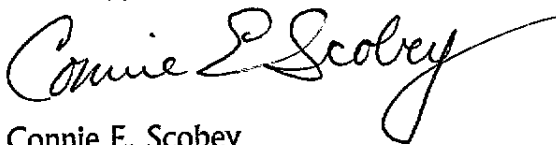

ARTICLES OF INCORPORATION
OF
SCHOLARSHIP RECOGNITION, INC.**

- 1. To be eligible for recognition and/or awards, a student must be a graduating senior of Avon Park, Sebring, or Lake Placid High Schools, ~~must have a cumulative "B" average (GPA 3.00) (GPA 3.2)~~ (GPA 3.4) or above and must have the recommendation of the principals. (Adopted May, 1963; revised February 4, 1997; and revised January 22, 2002)**
- 2. Each scholarship award will be available for only five years and must be used within that time unless the Board of Directors waives this rule due to extenuating circumstances. (Adopted March 26, 1987)**
- 3. The Andrew Miracle Highest GPA in Highlands County plaque will be presented to the student with the highest GPA in the three high schools. (Adopted January 30, 1990, and revised April 5, 1990)**
