EXTRAORDINARY MEETING OF THE BOARD OF DIRECTORS IGLESIA DE DIOS PENTECOSTAL MOVIMIENTO INTERNACIONAL, INC. 4940 Hoffner Avenue, Orlando, Florida 32812

The Board of Directors of IGLESIA DE DIOS PENTECOSTAL MOVIMIENTO INTERNACIONAL, INC. which name was erroneously amended to IGLESIA DE CRISTO MARANATA INC adopted and approved unanimously the following RESOLUTION at a duly convened emergency meeting of the Board on January 3, 2011, for the said RESOLUTION to be attached to new Articles of Amendment to Articles of Incorporation of IGLESIA DE CRISTO MARANATA, INC. to correct the name change error, as follows:

RESOLUTION

WHEREFORE Pastor Marianita Hernández of one of our local churches formerly authorized to operate under our Council's corporate authority and under our State as well as Federal tax exempt designations ceased to be a part of this religious Council because of her proximity to another established local church and she decided to operate her church as an independent entity.

WHEREFORE Pastor Marianita Hernández was under the belief that the corporate and exemption authorities given her were of her exclusive use and she proceeded in good faith but grossly in error and without prior consultation with this Board, to amend the name of our corporate Council so she could operate her independent church under a different name, which led her to file on December 1st, 2010 Articles of Amendment to Articles of Incorporation of IGLESIA DE DIOS PENTECOSTAL MOVIMIENTO INTERNACIONAL, INC. to a new name of IGLESIA DE CRISTO MARANATA, INC. which filing was not supported by the approval nor corporate resolution of this Board.

WHREFORE our Council IGLESIA DE DIOS PENTECOSTAL MOVIMIENTO INTERNACIONAL, INC. has never ceased to exist under such name since its initial filling on March 22, 1963 under Document Number 705368, FEI/EIN Number 592044508 as set forth in its compilance reporting the last of which was filed on February 17, 2010 with its 2010 Not for Profit Corporation Amended Annual Report, nor has its Board ever authorized a name change or corporate Amendment other than the one being adopted at this meeting.

WHEREFORE the above erroneously filed amendment is interfering with the normal conduct of its corporate and administrative business and its financial transactions with the community and its banking entities.

NOW, THEREFORE, IT IS VOTED AND UNANIMOUSLY APPROVED that Articles of Amendment to Articles of Incorporation be immediately and personally filed with the Division of Corporations of the Florida State Department in Tallahassee to amend the name of IGLESIA DE CRISTO MARANATA INC. and restore the name to its correct name of IGLESIA DE DIOS PENTECOSTAL MOVIMIENTO INTERNACIONAL, INC. and that Pastor Marianita Hernández sign on the RESOLUTION document issued by the Board Secretary to attest to the veracity of the statements made herein.

IN WITNESS WHEREOF I, NOEMI PEREZ, Secretary of the Board, issue this RESOLUTION in Orlando, Florida this 3rd day of January, 2011, after securing the signature of Pastor Marianita Hernández attesting to the veracity of the RESOLUTION statements, as required by the Board.
