

Whereas, Bethel Assembly of God (Sovereign Assembly) under the leadership of Charles A. Oswalt for 19 years enjoys debt free property, and facilities, and

Whereas, both congregations feel they can best serve and minister to the Melbourne are as one congregation, be it therefore resolved that,

- 1. Both congregations merge as one taking the name Lighthouse Assembly of God of Melbourne, Inc.
- 2. Pastor Roger Hackenberg, JR will become Senior Pastor.
