ARTICLES OF AMENDMENT TO ARTICLESOF INCORPORATION OF RINGLING SCHOOL OF ART AND DESIGN, INC

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida non-profit corporation adopts the following article of amendment to its Articles of Incorporation.

FIRST: ARTICLE V, Subparagraph (a), is hereby amended to be as follows

ARTICLE V. MANAGEMENT OF AFFAIRS OF THE CORPORATION

(a) The government and management of the affairs of the corporation shall be vested in a Board of Trustees of not less than three (3) persons. The maximum number of persons who may be elected to the Board of Trustees shall be provided in the By-Laws of the corporation, as may be amended from time to time, and by such officers as may be elected by the Board of Trustees as provided in the By-Laws.

SECOND: The date of adoption of the amendment was April 14, 2005.

THIRD: Pursuant to the provisions of the Articles of Incorporation and By-laws, the amendment was adopted by the members of the Board of Trustees at a regular meeting on the above date by greater than a two-thirds vote of the members present.
