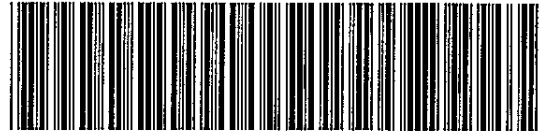



**ARTICLES OF AMENDMENT**  
**TO ARTICLES OF INCORPORATION**  
**OF RINGLING SCHOOL OF ART AND DESIGN, INC**

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned as Florida non-profit corporation adopts the following article of amendment to its Articles of Incorporation.

FIRST: ARTICLE V, Subparagraph (a), is hereby amended to be as follows

**ARTICLE V.**  
**MANAGEMENT OF AFFAIRS OF THE CORPORATION**

(a) The government and management of the affairs of the corporation shall be vested in a Board of Trustees of not less than three (3) persons. The maximum number of persons who may be elected to the Board of Trustees shall be provided in the By-Laws of the corporation, as may be amended from time to time, and by such officers as may be elected by the Board of Trustees as provided in the By-Laws.

SECOND: The date of adoption of the amendment was April 14, 2005.

THIRD: Pursuant to the provisions of the Articles of Incorporation and By-laws, the amendment was adopted by the members of the Board of Trustees at a regular meeting on the above date by greater than a two-thirds vote of the members present.

IN WITNESS WHEREOF, the undersigned president and secretary of this corporation not for profit have executed on behalf of the corporation this Articles of Amendment this 15th day of June 2005.
