

TO

Pursuant to the provisions of Section 617.1006, Florida Statutes, the above named Florida corporation not for profit adopts the following amendment to its Articles of Incorporation.

FIRST: ARTICLE I of the Articles of Incorporation, as previously amended, is hereby amended to be as follows:

ARTICLE I.  
NAME

The name of this corporation shall be RINGLING COLLEGE OF ART & DESIGN, INC.

SECOND: The date of adoption of this amendment was April 12, 2007.

THIRD: Pursuant to the Articles of Incorporation and Bylaws, this amendment was adopted by the members of the Board of Trustees of the corporation at a regular meeting on April 12, 2007, at which a quorum was present, by greater than a two-thirds vote of the members present.
