THE UNDERSIGNED, being authorized to execute and file these Amended and Restated Articles of Incorporation, hereby certifies that:

FIRST: These Amended and Restated Articles of Incorporation amend and restate the Articles of Incorporation of THE RIVER FOUNDATION, INC. (this "Corporation"), as heretofore amended.

SECOND: The Articles of Incorporation of this Corporation were filed with the Florida Department of State on July 12, 1951, and this Corporation's State of Florida Document Number is 705789.

THIRD: The Articles of Incorporation of this Corporation, as hereby amended and restated, shall hereafter provide as follows:
