**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
BEULAH BAPTIST CHURCH OF PENSACOLA, FLORIDA, INC.**

Pursuant to the provisions of Sections 617.1002 and 617.1006, *Florida Statutes*, BEULAH BAPTIST CHURCH OF PENSACOLA, FLORIDA, INC. (document number 705805), a Florida corporation not for profit (the "Corporation"), hereby submits these Articles of Amendment for the purpose of amending its Articles of Incorporation as follows:

1. Article I. of the Articles of Incorporation is hereby amended and restated to read as follows:


**ARTICLE I. NAME.**

The name of the Corporation shall be FIRST BAPTIST CHURCH OF BEULAH, INC., a corporation not for profit.

2. The foregoing amendment was proposed and recommended by the Board of Trustees of the Corporation and adopted by the Members of the Corporation on June 4, 2017, in accordance with the provisions of Section 617.1002, *Florida Statutes*. The number of votes of the Members was sufficient for approval of the foregoing amendment.

3. These Articles of Amendment will become effective upon filing with the Florida Department of State.
