CERTIFICATE OF ADOPTION OF AMENDMENTS TO CHARTER OF UNIVERSITY OF ORLANDO

we, the undersigned, being members of the Board of Trustees of the University of Crlando, do hereby certify that a special meeting of the Board of Trustees was held on the campus of the University of Oriando August 12, 1971, in compliance with the charter and bylrvs of the corporation; that there were more than a quorum of trustees present at said meeting, and that the following resolution was offered to the Board of Trustees for its action, and was affirmatively voted for by all the trustees at the meeting, who constituted a majority of the members of the Board of Trustees.

RESOLVED that Article II of the charter of the University of Orlando be and the same is hereby amended by the addition of the following paragraph:

ARTICLE II

The college may establish and maintain in addition to an institution of higher learning, such institutions that will provide for students from the kindergarten age through the twelfth grade, a preparatory education designed and committed to the preparation of said students to obtain and achieve those qualifications needed to continue their education in an institute of higher learning. The Board of Trusteer may from time to time, as it deems fit, institute such pre-school or kindergarten, grammar school and/or preparatory school or schools as to the trustees seem prudent; and may operate said school or schools under such fictitious name or names as to the Board of Trustees seems expedient including, but not limited to, the Lake Highland Preparatory School.

FURTHER RESOLVED THAT the proper officers of this corporation be and they are hereby authorized to do any other and further acts, and pay any other and further fees requisite under the laws of the state of Florida, to amend the charter of University of Orlando as hereabove set forth.

That he is secretary of the University of Orlando, the non-profit cornoration named and described in the foregoing Certificate, that he has custody and possession of the minutes of such corporation, that JOSEPH S. GURNSEY is the president and chairman of the Board of Trustees, that the Certificate of Adoption contains a true and correct copy of a resolution including proposed amendment to the charter of said corporation by which Article II is amended, which was duly offered and adopted by unanimous vote of all the trustee, of the corporation present at a special meeting held August 12, 1971, which was duly and regularly called in accordance with the bylaws of the corporation, at which meeting more than a quorum was present at the time the resolution was adopted by an affirmative vote of more than a majority of the trustees of the corporation; and that said resolution was adopted in the manner and approved by the vote required by the charter and bylaws of the corporation, and in fulfillment of the requirements of the laws of Florida, and the charter and the bylaws of said corporation for the meeting of a non-profit corporation of Florida.
