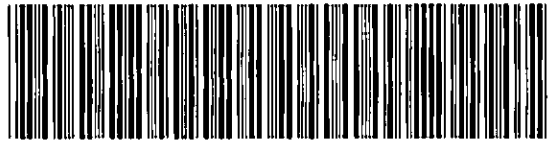

**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
COMMON GROUND CHRISTIAN CHURCH CORPORATION**

Pursuant to the provisions of Section 617.1006, Florida Statutes, Common Ground Christian Church Corporation, a Florida not for profit corporation (the "Corporation"), adopts the following amendments to its Articles of Incorporation:

1. Article V of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced to read as follows:

**"ARTICLE V**  
**Dissolution**

Upon a dissolution of Common Ground Christian Church Corporation (the "Corporation"), the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, as amended, or corresponding sections of any prior or future law, or to the federal, state, or local government for exclusive public purpose."

2. Article VIII of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced to read as follows:

**"ARTICLE VIII**  
**Bylaws**

The power to adopt, alter, amend, or repeal Bylaws of the Corporation shall be vested in the Board of Directors of the Corporation."

3. Article IX of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced to read as follows:

**"ARTICLE IX**  
**Amendments**

The Articles of Incorporation of the Corporation may be amended by resolution adopted by the Board of Directors of the Corporation."

4. The amendments were adopted on the 11<sup>th</sup> day of November 2020.

5. The amendments were adopted by the Elders of the Corporation and were approved by the Board of Directors of the Corporation. There are no members entitled to vote on the amendments.
