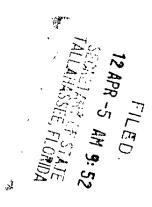

ARTICLES OF INCORPORATION

OF

Society for the Prevention of Cruelty to Animals, Tampa Bay, Florida, Inc.

ARTICLE I Name and Address

The name of the Corporation shall be: Society for the Prevention of Cruelty to Animals, Tampa Bay, Florida, Inc.

The Corporation's principal office address is: 9099 130th Avenue North, Largo, Florida, 33773-1441.

ARTICLE II Purpose

The Corporation's purpose shall be to promote the welfare of all animals in Tampa Bay, Florida and vicinity; to protect and shelter the sick and injured, the homeless and unwanted animals; to find loving homes for homeless animals; to educate the public concerning the humane care of all animals; and to assist in the enforcement of laws and ordinances for animal protection.

The purpose and object of this corporation shall be to promote the welfare or all animals in the Tampa Bay, Florida and vicinity, to care for and find homes for animals; to prevent and to provide effective means for the prevention of cruelty to animals; to encourage kindness toward animals and to assist in the enforcement of all laws and ordinances for their protection.

ARTICLE III Term of Existence

The Corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE IV Board of Directors

The Board of Directors may consist of not less than three (3) nor more than twenty-seven (27) persons who shall be appointed by the Board of Directors in accordance with the By-Laws.

ARTICLE V Registered Agent

The initial Registered Agent of the Corporation shall be: Martha Boden.

The address of the initial Registered Agent is: 9099 130th Avenue North, Largo, Florida 33773-1441.

These Amended: Articles of Incorporation were adopted by the members and Board of Directors on the 28th day of November, 2011. Pursuant to Florida Statute Section 617.100 members were entitled to vote on these Amended and Restated Articles of Incorporation. These amended articles of incorporation supersede the original Articles of Incorporation and all amendments thereto.
