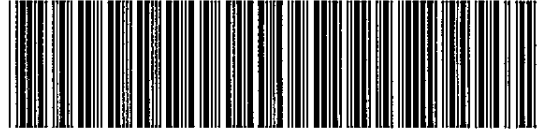

FIRST: The name of the corporation is COLONIAL COURT APTS. ASSOCIATION, INC.


SECOND: Adoption of dissolution


