2. Article One of the Articles of Incorporation of FLORIDA FIRE EQUIPMENT DEALERS, INC. was amended as follows:

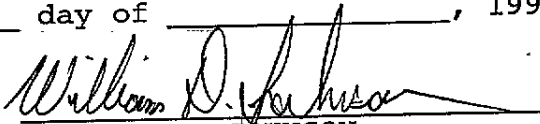
ARTICLE ONE

The name of this corporation is FLORIDA FIRE EQUIPMENT DEALERS ASSOCIATION, INC.

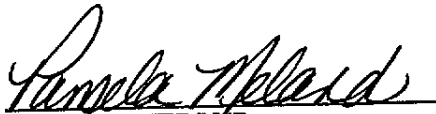
3. Members were not entitled to vote on this Amendment.

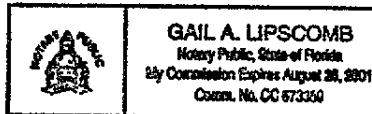
