


On Sept. 19, 2006, we were very surprised to find that our Greater Seminole Area Chamber of Commerce had not been reinstated as a not-for-profit corporation. We telephoned your division and spoke to one of your representatives, named Yula. She was polite and helpful, and after looking up our Document #706373, acknowledged that the proper amount of \$61.25 (check #10960) was received by the Division of Corporations and cashed prior to April 18, 2006. Yula explained further that our paperwork was not processed. The reason given was that we had failed to sign the paperwork. She said the form was mailed back to us to be signed on April 18. It was sent to our Post Office #3337, which for some unknown reason, we did not receive.

We are sending another form, with signature, and hope this will suffice. We feel we were in no way negligent in this matter and should not be penalized.
