ARTICLES OF AMENDMENT

1. The following provisions of the Articles of Incorporation of the Harbour Heights United Methodist Church, Inc., a Florida corporation, filed in Tallahassee on December 6, 1963, and amended September 8, 1968, be and they hereby are amended in the following particulars:

Article I be and it hereby is amended to read as follows: The name of this corporation shall be CHRIST COMMUNITY UNITED METHODIST CHURCH, INC.

It is further resolved that the President and Secretary of this corporation be and they are hereby authorized and directed to make, execute and acknowledge a Certificate under the corporate seal of this corporation, embracing the foregoing Resolution, and to cause such Certificate to be filed and recorded in the office of the Secretary of State in the manner required by Florida Statutes.

The above and foregoing Amendment was adopted pursuant to Article XI of the Articles of Incorporation, at a meeting of the charge conference of this corporation held on the 26th day of September, 1999, at which a majority of members of said quarterly conference present and voting approved said Amendment.
