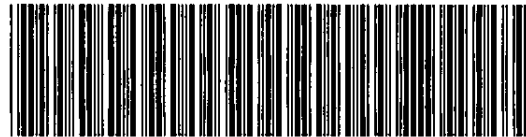

In addition, the First Advent Christian Church of Tampa, Tampa, Florida is not required to be in good standing with any conference or entity. The First Advent Christian Chruch of Tampa,Tampa, Florida shall be an independent entity which shall be self governing here after and will be free to determine the distribution of any of its assets to any class code 501(c) (3) in accordance to the law by a majority vote of active members. Furthermore, any dissolution or termination of the First Advent Christian Chruch of Tampa, Tampa, Florida will be determined solely by its active members. An active member shall be an individual voted into membership and not delinquent in attendance for more than 6 weeks and not delinquent in giving of tithes and offerings. An inactive status will be given to members who are delinquent, requiring a 2/3 vote of active members to reinstate an active status.
