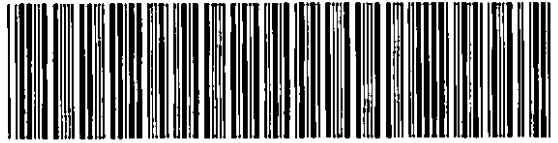

Amending Article V. The business affairs of this corporation shall be managed by a Board of Deacons,
such management to be subject to the approval of the church, and said Board to be composed of not less than
three (3) members and said Board of Deacons shall be elected from and by the membership. Term and election
process shall be governed by the Bylaws of the Corporation. Trustees shall act as Board of Directors.

Adding Article IX: Upon the dissolution of the organization, none of its funds or assets shall be distributed to any
director, officer, deacon, trustee, member or any other individual. The Church board shall, after paying
or making provision for the payment of all of the liabilities of the church, distribute funds and assets
for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code,
or corresponding section of any future federal tax code. Any such funds or assets not so disposed
of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation
is then located, exclusively for such purposes or to such organization or organizations, as said Court shall
determine, which are organized and operated exclusively for such religious purpose.
