CHURCH OF CHRIST OF WEST PALM BEACH, INC.


Article I of the Articles of Incorporation is hereby amended to read

IN WITNESS WHEREOF, the undersigned, President, of this Corporation have executed these Articles of Amendments, this 15th day of July 1998.


