We, the undersigned, being five in number, hereby associate ourselves together for the purpose of becoming a body corporate not for profit under the laws of the State of Florida, and being of the age of twenty-one years or more, do hereby certify and make, subscribe, acknowledge, and file in the Office of the Secretary of State of the State of Florida, this certificate of incorporation.

ARTICLE I

NAME.

The name of this corporation shall be PENSACOLA HERITAGE FOUNDATION, INC., and the principal place for the transaction of its business shall be 619 North Baylen Street, Pensacola, Escambia County, Florida, but the corporation shall have the right to establish other places of business as shall be determined from time to time by the Board of Directors.

ARTICLE II

PURPOSE.

The purpose or purposes for which the corporation is organized are to encourage the maintenance, preservation and reconstruction of the early dignity and beauty and heritages of the City of Pensacola in Escambia County, Florida, by doing all such acts as may be necessary in order to stimulate interest in the local history and landmarks of that City; to foster the preservation of the historical architectural character of that City; to preserve, improve, and protect its ancient church yards and surrounding properties and those buildings, streets, ways, sections, and approaches having architectural and historical worth; and to secure cooperation and unity of action between individual citizens and other groups or societies as may be necessary in the promoting of the general social welfare of the

City of Pensacola and its surrounding community. The activities of the corporation may be carried on within all or any part of the United States of America either directly or through cooperation with or financial contributions to any public or private agency, foundation, religious organization or corporation, welfare fund and educational institutions having like purposes and objects for which this corporation is organized. All or any part of the corpus, income, earnings, funds or other property of the corporation may be used by the Board of Directors for the purposes for which the corporation is organized, in such amounts, at such times, and in such manner as the Board of Directors shall deem necessary and advisable to carry out the purposes of the corporation, and the corporation shall have the right to receive from persons, firms and corporations voluntary gifts of money and other property to be used by the corporation for the purposes of its incorporation, and it shall in general exercise such other powers as the Directors may deem requisite to promote the general purposes of the corporation as set forth above and as permitted by law and to have all other powers with which a corporation of its class is endowed.

### ARTICLE III

#### MEMBERSHIP.

The members of this corporation shall consist of the undersigned subscribers, whose names and residences are as shown below, and such other individuals as may be admitted to membership by the duly constituted Board of Directors, according to the by-laws which may provide for contributing, sustaining, regular or associate membership and which shall define the respective powers of each class. All members shall not be less than twenty-one years of age, shall be citizens of the United States of America and of the State of Florida, shall be of good moral and religious habits, character and reputation, who will add dignity and strength to and respect for the corporation and its members and the purposes for which the corporation is organized and who shall be loyal to the principles and

purposes for which the corporation is organized. Members shall be admitted on written or oral application made by them to the Board of Directors of the corporation, and if admitted to membership, the minutes of the Board of Directors shall evidence their admission. The Board of Directors shall have the right, if so provided for in the by-laws of the corporation, to limit the number of members of the corporation, but at no time shall there be less than five members. Membership meetings and the constitution of a quorum shall be subject to provisions set forth in the by-laws.

#### ARTICLE VI

##### OFFICERS AND ANNUAL MEETING

The affairs of the corporation shall be managed by a President, a Vice-President, a Secretary, and a Treasurer, and also by a Board of Directors consisting of not less than three nor more than ten members of the corporation in good standing. The officers of the corporation and the Board of Directors shall be elected for a period of one year. The Board of Directors shall be elected at each annual meeting of the members of the corporation or at any special meeting of the members of the corporation as shall be provided for in the by-laws of the corporation providing that a majority of the members of the corporation shall be present at such meeting and voting. The officers of the corporation shall be elected by the Board of Directors at each annual meeting of the Board of Directors, or at such special meeting of the Board of Directors called for such purpose at which a majority of the Directors are present and voting. Officers and Directors shall serve without compensation and shall be active members thereof and shall continue to hold their respective offices until their respective successors have been elected. In addition to the above-named persons, the President, the Vice-President, the Secretary and the Treasurer shall serve as ex-officio members of the Board of Directors with the President acting as the Chairman.

#### ARTICLE VIII

##### EXECUTIVE COMMITTEE

There shall be an Executive Committee to be designated by the active Board of Directors which shall have all the rights and privileges of the Board except the right to fill a vacancy in the Board of Directors, to change the by-laws or to make regulations which govern the corporation.

#### ARTICLE IX

##### AMENDMENT OF BY-LAWS

Amendments to these Articles of Incorporation may be proposed in writing by any member of the Board of Directors at any regular meeting of the Board. If the proposed amendments shall be such as is lawful for a corporation not for profit under the laws of the State of Florida and for the purposes for which this corporation is organized, the Board of Directors shall call a meeting of the members of the corporation in the manner provided for by the by-laws, to consider the adoption of such proposed amendments. If at such meeting the majority of the members vote to

adopt such amendments, the same shall then be considered adopted. Copy of the amendments so adopted, with thereon a certificate of its approval by the majority of the members of the Board of Directors, sealed with the corporate seal, signed by the Secretary, and executed and acknowledged by the President or Vice-President, shall then be prepared and filed with the Secretary of the State of the State of Florida for his approval, and when so approved, these Articles of Incorporation shall be considered as having been amended to include the amendments so proposed and adopted.

#### ARTICLE X

##### BY-LAWS

The corporation shall have authority to make and adopt by-laws for the government of the corporation and to amend such by-laws from time to time. By-laws shall be made, amended, altered and rescinded by vote of majority of the active Directors of the corporation at a meeting duly called and held for such purpose or at a meeting held without notice at which not less than four-fifths of the members of the Board of Directors of the corporation are present and voting and who shall signify by their consent to the holding of such meeting and approval of all acts taken at such meeting on the minutes of the meeting. All members of the Board of Directors of the corporation shall have equal voting rights and standing and there shall be no separate class of members in the Board of Directors. Each Director shall be entitled to one vote at all meetings of the Directors of the corporation and no Director shall be entitled to vote by proxy at any meeting of the corporation unless so authorized by the by-laws of the corporation. The by-laws of the corporation shall provide for the time and place of holding regular and special meetings of the Board of Directors and regular and special meetings of the members of the corporation.

#### ARTICLE XI

The corporation shall have power and authority to contract indebtedness for and on behalf of the corporation, for the benefit of and for the purposes of the corporation; to purchase and otherwise acquire and to lease, and to

sell and otherwise dispose of, mortgage and encumber real and personal property and interests in real and personal property located in the State of Florida or elsewhere for the use and benefit of the corporation, for such property approved by a majority vote of the Board of Directors of the corporation, at any meeting of said Board of Directors, or at any regular or special meeting of the executive officers of the corporation at which the said Board of Directors is present. All deeds of conveyances, leases, mortgages and other instruments necessary and required to be executed by and in behalf of the corporation, shall be executed in the name of the corporation by its President or Vice-President, attested to by its Secretary and the corporate seal of the corporation affixed thereto. All such instruments and documents so executed shall constitute a binding obligation on the corporation. The corporation shall also have power and authority to do all other acts and things which under the present and future laws of the State of Florida governing corporations not for profit shall be authorized to be done and performed.

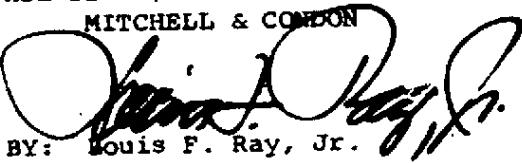

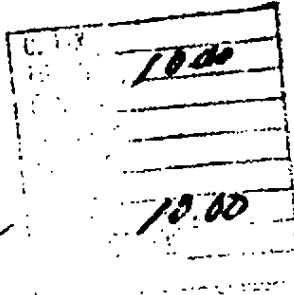

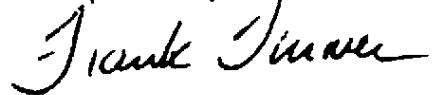
