TO THE ARTICLES

ARTICLE IX

Amendments

Amendments to the Articles of Incorporation shall be adopted in the following manner:

2. A resolution approving a proposed amendment may be proposed by either the board of directors or by the membership of the Association and after being proposed and approved by one of such bodies, it must be approved by the other. Such approvals must be by all a majority of the directors and by not less than 75% a majority of the members or the Association. Directors and members not present at the meeting considering the amendment may express their approval in writing.
