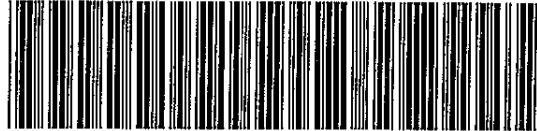

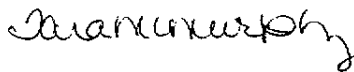

to
ARTICLES OF INCORPORATION

Temple Baptist Church of Titusville, Florida, Inc.

Amendment Adopted:

Article XII

- A. No part of the net earnings of Temple Baptist Church shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that Temple Baptist Church shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of Temple Baptist Church shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501c3 of the code, corresponding section of any further federal tax code, or (b) by an organization, contributions to which are deductible under section 170c 2 of the United States Internal Revenue Code, or corresponding section of any further tax code.
- B. Upon the dissolution of Temple Baptist Church, assets shall be distributed for one or more exempt purposes within the meaning fo section 501c3 of the code or corresponding section of any future federal tax code, or shall be distribute to the federal government, or to a state or local government for a public purpose.
