Re:

In follow up to our telephone conversation today, I am providing the follow up documentation to reinstate the above listed corporation to active status. The above referenced letter from Ms. Leslie Sellers of your office (Exhibit #1) indicated that FWEA had not filed a 1999 corporate annual report and that our organization had been administratively dissolved or its certificate of authority was revoked as a result of this alleged failure to file. Yet I have a cancelled check (Exhibit #2) which indicates that we did file and the State of Florida did cash our check. You informed me today that your records indicate that our forms were incorrectly filled out and were returned to my address. I never received them, so I had no way of knowing that there was a problem since you did not follow up to see why they had not been returned.

Ms. Sellers' letter indicated that at least 3 directors or trustees have to be listed and that the letter "D" or "T" should appear after their name. All of the officers of FWEA are also on the Board of Directors for the organization. Nowhere in the instructions did I see that there had to be at least 3 "D's" or "T's" on the form. In any event, I am resubmitting the forms for 1999 and 2000 with the appropriate number of "D's" after the names. Hopefully this will satisfy your needs.

I do not believe that the Florida Water Environment Association should have to pay the \$175 reinstatement fee in that it is clear that (1) the 1999 forms were submitted in a timely fashion (Evidence the fact that the State cashed our check) and (2) while your records indicate that the forms were returned to my address for further additions, they were <u>never</u> received by this office.

In conclusion, after you have straightened this all out in your files, I would appreciate a written response that all issues have been resolved and that the Florida Water Environment Association is back in the good graces of the Florida Department of State.
