E. ARTICLE II: Purpose

Oasis Church of Winter Garden, Inc. is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. As a means of accomplishing the above purposes and methods, the Corporation shall have the following powers: (a) To receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work. (b) To raise and assist in raising funds for the purposes herein set forth. (c) To acquire, own, lease, mortgage and dispose of property both real and personal. (d) To accept property and donations in trust for charitable purposes.

The property of the Corporation is irrevocably dedicated to educational and charitable purposes, and no part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, directors, officers or other private persons except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c) (3) purposes.

F. ARTICLE III: Mission Statement

Grow Faith. Give Hope. Go Love. 1 Corinthians 13:13.

- a) Bible: We believe the application of a Bible Centered, Spirit empowered teaching is the catalyst for transformation in individuals' lives and in the church community.
 2 Timothy 3:16-17.
- b) **Prayer:** We believe in the power of prayer. Prayer is a tool by which we create sacred places in a secular world. Philippians 4:6.

- c) **Growth:** We believe followers of Christ should demonstrate unquenchable desire for continuous growth. Like every relationship, God wants us to grow in our knowledge of His love and grace. When we cease to grow, we cease to be healthy and eventually cease to live. Healthy church naturally grows. 2 Peter 3:18.
- d) **Service:** We believe the church exists to mobilize faithful followers of Christ to serve the world. We exist to serve; therefore, whatever needs God places before us, we will do whatever it takes with the help of the Holy Spirit to meet those needs. The world needs the local church. Mark 10:45.
- e) **Diversity:** We believe the gospel has the power to break through cultural, age and socioeconomic barriers to creating a unique community that embraces everyone. Revelation 7:9.
- f) Community: We believe life-change happens best in community where trust and commitment towards each other is built. This is where discipleship happens. Acts 2:42-47.
- g) Excellence: We believe God is honored when we pursue excellence in our respective responsibilities. Colossians 3:17.

ARTICLE IV: Government

The government of this church shall be conducted in accordance with the By-Laws of Oasis Church of Winter Garden, Inc.

ARTICLE V: Board of Trustees

The consistory of this church shall constitute the Board of Trustees of this corporation, and as such, shall have all the powers over the temporalities of this church as prescribed by civil law and the by-laws of Oasis Church of Winter Garden, Inc.

ARTICLE VI: Membership

Members may be admitted to this corporation by proper application to the consistory. The consistory shall judge the applicants' fitness for membership on the basis of the Word of God and such rules as may be adopted by the assemblies of Oasis Church of Winter Garden, Inc.

ARTICLE VII: Terms of Existence

This corporation is to exist perpetually. In the event of any schism in this church, those members of the congregation who remain true to Oasis Church of Winter Garden, Inc. shall constitute the lawful congregation of this church, and the assets and estate of this church shall be held and enjoyed exclusively by such adherents.

ARTICLE VIII: By-Laws

The by-laws of this corporation shall be those which apply to Oasis Church of Winter Garden, Inc. In addition, the consistory may, be a majority vote of those present, make such local regulations as it sees fit, and by a 2/3 majority vote of those present amend or rescind such local regulations. At any meeting of the consistory where by-laws are made, amended or rescinded, a majority of the consistory must be present.

ARTICLE IX: Amendments

Amendments to these Articles of Incorporation may be adopted by the consistory by a two-thirds majority; provided however that no amendment may be adopted which conflicts with the by-laws of Oasis Church of Winter Garden, Inc., or the clear teachings of the Bible. A majority of the consistory must be present at any meeting passing on such amendments.

ARTICLE X: Address

The post office address of the principal office of this corporation in the State of Florida is 607 Avalon Road, Winter Garden, Florida 34787.

ARTICLE XIV: Dissolution

Upon termination or dissolution of Oasis Church of Winter Garden, Inc., any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(3(c) of the Internal Revenue Coede of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the termination or dissolving corporation.

The organization to receive the assets of Oasis Church of Winter Garden, Inc. hereunder shall be selected by the discretion of a majority of the managing body of Oasis Church of Winter Garden, Inc. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against Oasis Church of Winter Garden, Inc. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose which at least general includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

ARTICLE XV: Property and Debt

Debts or liability of this corporation, payable to persons or agencies other than Oasis Church of Winter Garden, Inc., shall never exceed two-thirds the value of the property of the corporation.
