Dear Sir,

The North Merritt Island Little League is requesting the waiver of the reinstatement fee. Because of the multiple hurricanes endured by the Space Coast (and Florida) in 2004, causing damage to all areas of our every day lives – business, work, homes, and multiple programs supporting the children in our county, this requirement went unnoticed.

The hurricanes impacted the county's efforts to complete the playing fields and the new building supporting the Little League. The focus was on this effort by the Parks and Recreation and the North Merritt Island Little League Board. The start of our 2005 season in March was also delayed because of the hurricane impacts.

In addition, this office was also impacted by the hurricanes. Required travel in support of the government (NASA in support of the Shuttle) was also impacted. Travel was delayed until late September of 2004 for CONUS landing sites and then required in March and April of 2005 for European (France) landing sites. An additional trip was required for landing sites in Spain during August of 2005.

As of October 2005, the NMILL will have a new board; the Reinstatement Form has been update to reflect this information.

And finally, please consider this request, as any late fees come from money designated for the children of Brevard County.
