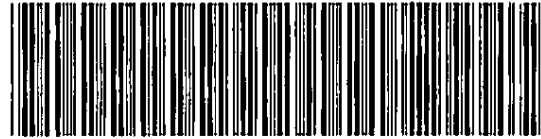

FIRST:

The name of the corporation being dissolved is "**Atlantic Boulevard Baptist Church, Inc.**"

SECOND:

The document number of the dissolving corporation is **707448**

THIRD:

A meeting of members of the Church was validly called and held in accordance with the Church's bylaws on or about December 8, 2022. At such time a resolution to dissolve the Church was adopted by the members eligible to cast a vote. The final tally of such vote was as follows:

A total of six (6) votes were cast.

6 were in favor of the resolution.

0 were opposed.

The result of the vote was to approve the dissolution of the Church.

FOURTH:

The effective date of this dissolution shall be February 28, 2023.

FIFTH:

As part of the approved resolution to dissolve the church corporation, the members voted to transfer all of the Church's assets to the parties/entities set forth on the Distribution Plan attached hereto as Exhibit "A". Upon such transfer, **Atlantic Boulevard Baptist Church, Inc.** shall have no further assets or known obligations to any third party(ies).

ATLANTIC BOULEVARD BAPTIST CHURCH, INC.

Plan for the Distribution of Assets

2023 JAN 13 AM 10:36

The Atlantic Boulevard Baptist Church, Inc. (the "Church") voted on or about August 8, 2022, to dissolve said corporation. As part of such dissolution, the Church has agreed to distribute all of its current and remaining assets in the following manner:

- 1) All current and existing liabilities and obligations of the Church will be paid or otherwise discharged on or before December 31, 2022.
- 2) Prior to the effective date of dissolution (i.e., December 31, 2022), the real-property owned by the Church will be sold to a buyer for market value.
- 3) Between the closing date of the sale of real-property and the effective date of the Church's dissolution, any and all Church bank accounts, shall be closed. Any monies that may exist in any such accounts shall be disposed of in the following manner:
 - A) 20% of the net proceeds of the sale of the Church's real-property shall be disbursed as a one-time contribution to Rev. James T. Rigdon Sr. as a retirement gift for 45 years of faithful service as pastor of Atlantic Boulevard Baptist Church. \$65,000 of such amount shall be directed to Pastor Rigdon's Guidestone account, with the balance paid as compensation with the appropriate payroll tax withholdings.
 - B) The remainder of the sale proceeds shall be evenly distributed among the following faith-based ministries:
 - a. **Samaritan's Purse:** PO Box 3000, Boone, NC 28607 - To help in the ongoing world-wide relief effort of this great organization as they seek to be the hands and feet of Jesus to those who are hurting most.
 - b. **Florida Baptist Convention:** 6850 Belfort Oaks Pl, Jacksonville, FL 32216 - Investing in the ongoing work of Church Planting and Disaster Relief
 - c. **Our Daily Bread:** PO Box 2222, Grand Rapids, MI 49501 - For the continued publication of daily devotions to help believers grow in their faith.
 - d. **Little Creek Missionary Baptist Church:** 5027 Little Creek Road, Jessup, GA 31546 - In honor of Mrs. Florence Harris in recognition for the faithful ministry of this church to its community.
 - e. **Shindler Drive Baptist Church:** 7100 Shindler Dr., Jacksonville, FL 32222 - To help this sister church in its continued ministry to reach the people of Duval and Clay County with the Gospel of Jesus Christ.

- f. **Battle Branch Baptist Church:** PO Box 483, Clayton, Georgia 30525 – To assist this sister church in its continued ministry to reach the people of Rabun County with the Gospel of Jesus Christ.
- g. **Mountain Bible Church:** 18 Pine Meadow Rd, Livingston, MT 59047 - To assist this church and it's young pastor as the reach the people of Livingston Montana and the surrounding area with the Gospel of Jesus Christ.
- h. **Challenge Ministry International:** 5220 Shad Rd STE 407, Jacksonville, FL 32257 - To invest in this ministry as they continue to reach the people of Jacksonville with the Gospel of Jesus Christ.
- i. **Pate Ministries:** PO Box 893, Callahan, FL 32011 - Investing in the missionary work that is going in the nation of Ecuador reaching men, women, boys and girls with the Gospel of Jesus Christ
- j. **Helping Hands Foreign Missions:** 5043 Bristol Industrial Way, Buford, GA 30518 - Investing in the ongoing mission work in the nation of Uganda as they minister to orphans and widows as well as maintain a medical clinic.
- k. **Matthew Boyd (United World Missions Acct # 31415):** 205 Regency Executive Park Dr., Suite 430, Charlotte, NC 28217 - Investing in the ongoing work to reach all of Senegal and West Africa for Christ through Gospel radio stations and training national pastors and evangelists.
