ATTACHMENT TO ARTICLES OF AMENDMENT OF ROSARIAN ACADEMY, INC.

The Certificate of Reincorporation of Rosarian Academy (the original Charter having been filed in the Circuit Court of Palm Beach County, Florida on the 11th day of September, A.D., 1941, according to documents filed in this office), reincorporated under the corporate name of Rosarian Academy, Inc. (the "Corporation"), shall be amended by deleting Article III in its entirety and adding the following as Article III.

ARTICLE III

The Corporation is a nonprofit corporation, which shall be, operated exclusively for charitable, spiritual, educational or scientific purposes within the meaning of Section 501(c)(3) of the United States Internal Revenue Code of 1986, as amended from time to time and as supplemented by such pertinent regulations there under, as has or have been or hereafter may be, formulated. The Member of the Corporation shall be Dominican Veritas Ministries, Inc., an Illinois not-for-profit corporation.
