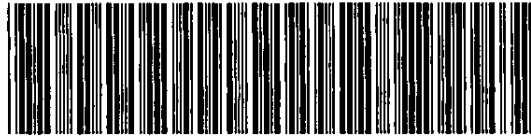

1. **Introduction:** The study aims to investigate the impact of the COVID-19 pandemic on the mental health of healthcare workers in the United States.

2. **Methodology:** A cross-sectional survey design was employed, involving 1,200 healthcare workers from various hospitals and clinics. Data was collected through an online questionnaire.

3. **Results:** The study found a significant increase in anxiety and depression symptoms among healthcare workers during the pandemic. Factors such as long working hours, exposure to COVID-19 cases, and lack of social support were identified as contributing factors.

4. **Conclusion:** The findings highlight the need for mental health support and interventions for healthcare workers during crises. Further research is needed to explore long-term effects and effective coping strategies.


