THE CARVER RANCHES-HYDE PARK HOMEOWNERS ASSOCIATION, INC.

The undersigned, acting as incorporator of a nonprofit corporation pursuant to Chapter 617, Florida Statues, adopts the following Articles of Incorporation.

ARTICLE 1 NAME

The name of the corporation shall be Carver Ranches-Hyde Park Homeowners Association, Inc., a Florida corporation not for profit, whose principal address/mailing address is c/o Cloreta Morgan, 4211 SW 26th Street, West Park, FL 33023.

ARTICLE II BOUNDARIES

The community to be represented by the corporation, generally known as Carver Ranches- Hyde Park is bounded starting at the Intersection of Southwest 38th Avenue and Southwest 28th Street to the Intersection of SW 48th Avenue; thence going North along the East Side of SW 48th Avenue to the Intersection with SW 25th Street; thence going West along the North Boundary of SW 25th Street to the Intersection with SW 56th Avenue; thence going West along the North Side of 21st Street to the Intersection with SW 58th Avenue; thence going West along the Boundary of SW 58th Avenue to the Intersection of SW 17th Street; thence going East along the South Boundary of SW 17th Street to the Intersection with Southwest 40th Avenue: thence going South along the West Boundary of SW 40th Avenue to the Intersection of SW 25th Street; thence going East along the South Boundary of SW 25th Street to the Intersection of SW 38th Avenue; thence going South along the West Boundary of SW 25th Street to the Intersection of SW 38th Avenue; thence going South along the West Boundary of SW 38th Avenue to the Point of Beginning, which is known as the "CARVER RANCHES-HYDE PARK AREA," being within the City of West Park, the County of Broward and State of Florida.

ARTICLE III PURPOSE

The general purpose of this Corporation is to promote the following: Good Will, Welfare guidance and all other activities for homeowners which will directly or indirectly improve the welfare and economic conditions of homeowners within the Carver Ranches-Hyde Park boundaries.

- A. To exercise every and all other rights and powers conferred upon corporations formed under the General Nonprofit Low of the State of Florida, provided however, that the Corporation shall not engage in any activities or exercise any powers, that are not in furtherance of the specific and primary charitable and educational purposes of the corporation.
- B. All of the foregoing purposes and powers shall be exercised exclusively for charitable and educational purposes in such manner that the corporation shall qualify as an exempt organization under section 501(c) (3) of the Internal Revenue Code of 1954 and applicable state tax law provisions, as they are currently and shall hereafter be in force and effect.

ARTICLE IV MEMBERSHIP

The qualifications of members and the manner of their admission to this organization shall be as follows:

- A. Any adult person eighteen (18) years of age or over of good character and reputation who must both own real property and resides in the area known as the CARVER RANCHES-HYDE PARK AREA, in the City of West Park, the County of Broward and State of Florida.
- B. Membership shall be from year to year provided always that the members are in good standing.
- C. Dues shall be \$12.00 annually for members under the age of 65; \$6.00 annually for members 65 and older.
- D. Any member who is no longer a resident of the CARVER RANCHES-HYDE PARK AREA shall no longer be a member and shall lose all rights and privileges pf membership. Such person shall not be entitled to a refund of any dues paid.

ARTICLE V EXISTENCE

This Corporation shall have perpetual existence, unless dissolved under the laws of the State of Florida.

ARTICLE VI INDEBTEDNESS

The highest amount of indebtedness of liability to which the Corporation may at any time be subject shall be \$100.00, and never at any time may be greater than two-thirds of the value of the Corporation. The value of the real estate which this Corporation may hold, subject to the approval of the Circuit Judge, shall be \$100.00.

Each officer must be a member in good standing.

ARTICLE VIII PROPERTY, ASSETS, PROFITS AND NET INCOME

The corporation is formed solely for charitable and educational purposes. The corporation is not organized, nor shall it be operated for the purpose of generating pecuniary gain or profit and it will not distribute any gains, profits or dividends to the members thereof, or to any individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its specific and primary purposes. The property, assets, and surplus of the corporation are irrevocably dedicated to charitable and educational purposes, and no part of the income of the corporation shall inure to the benefit of any officer or member in or to the benefit of any individual.
