AMERICAN SOCIETY OF CLU & ChFC**

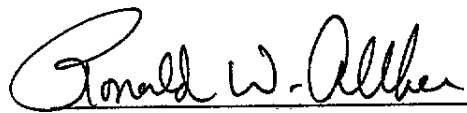
Pursuant to its Articles of Incorporation at Article IX, and upon affirmative vote of its membership this 17th day of February, 1999 the Central Florida Chapter of the American Society of CLU & ChFC adopts the following amendments to its Articles of Incorporation:

Article I is amended to change the name of the Corporation to: Central Florida Society of Financial Service Professionals, Inc.

Article V is amended to open membership to any person who has been approved for membership by the Society of Financial Professionals, Inc.

Article VII is amended to increase the elected board of directors to six (6) directors who will serve for a term of two (2) years each.
