

ARTICLE III

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The general nature of the business to be transacted by the EBENEZER WESLEYAN METHODIST CHURCH, INC., shall be as follows:

To establish and maintain a regular Methodist Church within the doctrines of the denomination, and to provide a place of public worship for the same in the city of Delray Beach, County of Palm Beach, and State of Florida at 201 S. W. 6th Avenue, Delray Beach, Florida. To establish maintain and conduct schools for religious instruction, mission churches, and to further other religious, educational and charitable work. And to that end, may adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with law and not inconsistent with these Articles Of Incorporation.

To acquire, buy, hold, own, sell, exchange, convey, lease, or otherwise dispose of goods, lands and chattels, effects and merchandise. To mortgage, lease, hypothecate, convey, exchange, and dispose of lands and chattels. To acquire, by gift, annuity, bequest, or otherwise, property, both real and personal or otherwise, and to promote the diffusion of religious literature and education in accordance with the Biblical Teachings of the Wesleyan Methodist Church.
