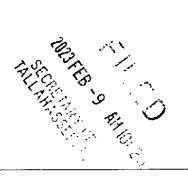

TO THE ARTICLES OF INCORPORATION

IX AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

. . .

2. A resolution approving a proposed amendment may be proposed by either the Board of Governors or by the membership of the Association, and after being proposed and approved by one of said bodies, it must be approved by the other. Such approval must be by seventy-five (75%) percent a majority of the members of the association. Governors and members not present at the meetings may express their approval in writing.
