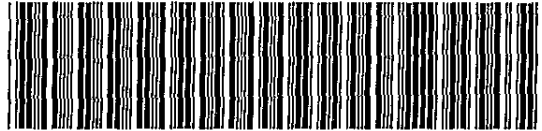

**ARTICLES OF INCORPORATION  
OF**

**A Florida Nonprofit Incorporation**

The Undersigned, majorities of whom are citizens of the United States,  
desiring to form a Non-Profit Corporation under the Non-Profit Corporation  
Law of the State of Florida,  
do hereby certify:

**ARTICLE I**

**NAME OF CORPORATION  
LOCATION OF PRINCIPAL OFFICE**

Name of Corporation: **JESUS CHRIST THE TRUE FREE WILL  
HOLINESS CHURCH, INC.**

The name of the Corporation shall be as follows: **JESUS CHRIST THE  
TRUE FREE WILL HOLINESS CHURCH, INC.**

The principal location of the Incorporation is 333 Navy Blvd., Warrington,  
Escambia County, Florida 32507. The Corporation is organized pursuant to  
the **Florida, Non-Profit Religious Corporation Code.**

**ARTICLE II**

**NON-PROFIT RELIGIOUS BENEFIT**

This **Religious Corporation** is a person authorized to transact business. No  
one may have its name or same name, it can sue, borrow, file bankruptcy  
and more. This Corporation is a Non-Profit Religious Benefit Corporation

and is not or organized for the private gain of any person. The Corporation is organized under GOD in whom we trust. In accordance to the 1<sup>st</sup> Amendment of the United States Constitution and GOD Divine Status (1 Corinthians 12:28). This Religious Benefit Corporation is part of the Church, which is the body of our Lord and Savior Jesus Christ to promote religious activities. This Corporation is tax-exempt and can receive tax-deductible contribution as outline in IRS Publication 557 and Application 1023. This Corporation is not required to file annually tax returns for church or religious related business. This religious Corporation shall establish and carry out business related to but, not limited to: The Religious Creed; By-Laws, Standard Operational Procedures, Divine Doctrine and other related religious activities.

### **ARTICLE III**

#### **PURPOSE**

This Corporation, **JESUS CHRIST THE TRUE FREE WILL HOLINESS CHURCH, INC.**, is an Non-Profit Religious Benefit Corporation organized and operated exclusively for Religious, Educational, Charitable, and Benevolent purposes with the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The general purposes and object of this corporation shall be for religious worship and instruction, to conduct and form churches, schools, and other institutions connected therewith of an religious, Charitable, Educational, and Benevolent character to the end that its own members and other individuals may be generally instructed and guided concerning the Article of Faith, The Creed, The Revelation of One Lord, One Faith, and One Baptism, which precepts are generally followed by the Holiness Church; to impart spiritual enlightenment, to advance spiritual growth, enlightenment, moral and personal purity and evangelism among its own membership and the people of the community; to promote home missions and foreign missions; to aid in the spread of the gospel to the ends of the earth; to educate, prepare and ordain men and women for ministry in the church; and to adopt the necessary rules, regulations and procedures to promote growth of the church; and for the purpose of promoting the foregoing objects, this corporation shall have the right to acquire, either by gift or purchase, and to hold, own, sell, mortgage, lease encumber in any manner, acquire real estate in the form of land and/or building for the

improvement of its facility in accordance with the growth and programs established within the church which includes tangible and/or personal property for this corporation as needed by a majority vote of the Board of Directors/Trustees. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a Corporation exempt for federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IV**

##### **DURATION OF CORPORATION**

The term of existence of this Corporation shall be perpetual.

#### **ARTICLE V**

##### **CLASSES OF MEMBERS**

The present membership of **JESUS CHRIST THE TRUE FREE WILL HOLINESS CHURCH, INC.**, and those individuals hereafter admitted as Members shall constitute Membership of this Corporation. Every person who accepts the Articles of Faith, The Creed, The Revelation of One Lord, One Faith, One Baptism, The Precepts and Principles of this organized church is qualified and eligible for membership in the Corporation; and the manner of admission to membership in the corporation shall be by profession of faith in the True and Living God.



## ARTICLE VII

### FOUNDER/BISHOP

**S. A. Wainwright was the founder and revealer of JESUS CHRIST THE TRUE FREE WILL HOLINESS CHURCH, INC., on October 23, 1940. On December 17, 2001, by seal of the Secretary of State, Katherine Harris, Division of Corporation the Church/Corporation was reinstated in accordance with the Florida Department of State Division of Corporation. As of this date Prenecker Jackson has been inducted as the President and now Bishop of JESUS CHRIST THE TRUE FREE WILL HOLINESS CHURCH, INC., located 333 Navy Blvd., Warrington, Florida 32507. Bishop Prenecker Jackson will serve as Bishop for his natural life or until he resigns, become disable or designate a successor.**

## ARTICLE VIII

### ELECTION OF BOARD OF DIRECTORS/TRUSTEES

There shall be at least Five (5) and not more than seven (7) members of the Board of Directors/Trustees. The existing Board of Directors/Trustee shall elect or appoint any members of this Board by a two-third (2/3) majority vote, and The Board of Directors/Trustees shall appoint any and all Directors/Trustees in accordance with the By-Laws as adopted by this Board.

The Bishop shall be the Chairman of the Board of Directors/Trustees and the first Bishop by virtue of his dedication and work shall remain as Bishop for the period of his natural life, unless he resigns, becomes disabled to serve, or designate a successor.

## **ARTICLE IX**

### **AMENDING THE BOARD OF DIRECTORS/TRUSTEES**

The Board of Directors/Trustees of the Corporation shall be made only by a majority vote of two-thirds (2/3) votes by the Board of Directors/Trustees in accordance with the By-Laws adopted therein.

## **ARTICLE XI**

### **NO BENEFIT TO PRIVATE PERSONS**

The property of this Corporation is irrevocably dedicated to Religious, Charitable, and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof, or the benefit of any private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V thereof. No substantial part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

## **ARTICLE XII**

### **DISSOLUTION**

Upon the dissolution of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the designated successor exclusively for the purposes of the Corporation in which it was organized, or to such organization or organizations organized and operated exclusively for Religious, Charitable, and Educational, purposes as shall qualify as an exempt Corporation under Section 501(c)(3)



of the Internal Revenue Code, or the corresponding section of any future federal tax code.
