The Amended and Restated Articles of Incorporation of ANESTHESIOLOGISTS' PROFESSIONAL ASSURANCE ASSOCIATION, INC., a Florida corporation (the "Corporation"), which were filed on July 18, 1985 (the "Articles"), be and hereby are amended in the following manner:

1. Article V is hereby deleted in its entirety from the Articles and the following is hereby inserted in its place and stead:

"ARTICLE V

The purpose~~s~~ or purposes for which the Corporation is organized are:

To inform and educate physicians regarding risk prevention and management as it pertains to their medical practice and to provide:

1. Education in cause and prevention of death and disability during surgery and otherwise.
2. Promotion of programs of risk management directed towards the practice of medicine.
3. Continuous monitoring of national and regional liability insurance programs aimed to mitigate the financial effect of patient injury.
4. Where insurance is either unavailable or unaffordable, provide insurance programs for physicians.
5. Provide these programs with a network of highly qualified specialists and consultants in the fields of law, medicine, nursing, risk management, liability reinsurance and administration.

To do all things incidental to, or desirable in connection with, these purposes, including the acquisition of malpractice and other insurance for its members, and to have, enjoy and exercise all rights, powers and privileges which are now or which may hereafter be

conferred upon not for profit corporations organized under the Florida
Not For Profit Corporation Act."

The undersigned hereby certifies that the foregoing amendments to of the Amended and
Restated Articles of Incorporation of the Corporation were duly approved and adopted on
August 22, 1997 by written consent executed by all of the members of the Corporation's
Board of Directors as provided in the Articles and in accordance with Section 617.1002 of the Florida
Not For Profit Corporation Act. There are no members entitled to vote.
