### ARTICLES OF AMENDMENT TO THE

## ARTICLES OF INCORPORATION OF

# NAPLES SAILING AND YACHT CLUB, INCORPORATED

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida not-for-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

## **FIRST**

Article VI of the Articles of Incorporation are hereby revoked and in lieu thereof the following is inserted:

## ۷I

The affairs of this corporation shall be conducted by an Executive Board consisting of the officers and directors, which Board shall consist of no fewer than five (5) nor more than eighteen (18) persons. The Executive Board shall consist of three (3) Flag Officers (Commodore, Vice Commodore and Rear Commodore) and no less than two (2) or more than fifteen (15) Directors. The Flag Officers shall each serve for a term of one (1) year and each Director shall serve for a term of three (3) years, or until new Officers and for Directors are elected and qualified, if later. The Directors shall be divided into classes as shall be set forth in the By-Laws. On the day of each Election as set forth in the By-Laws, there shall be elected by the Regular Members of the Club, by secret ballot, one Regular Member to be Rear Commodore, and no less than two (2) or more than fifteen (15) Regular Members who shall serve as Directors. The candidate for Rear Commodore must have served as a member of the Executive Board. The member who is elected to serve in this position, will the following years move up to Vice Commodore and then to Commodore, completing his term of service over a three-year period as the top Flag Officer. There may be other Appointed Officers as the Commodore with the approval of the Executive Board may from time to time determine necessary for the operation of the corporation.

### SECOND

The date of the adoption of the amendment was May 30, 1997.

### THIRD

The amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.
