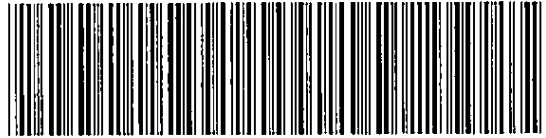

**AMENDED ARTICLES OF INCORPORATION  
OF  
NAPLES SAILING AND YACHT CLUB, INCORPORATED  
A FLORIDA NOT FOR PROFIT CORPORATION**

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

**FIRST**

Articles I, II, III, VI and XII of the Articles of Incorporation be deleted and revoked and in lieu thereof the following Articles I and II are inserted.

**ARTICLE I**

The name of this corporation shall be Naples Sailing and Yacht Club, Inc. and it shall be located in Naples, Collier County, Florida and its address shall be 896 River Point Drive, Naples Florida 34102.

**ARTICLE II**

The object and purpose of Naples Sailing and Yacht Club, Inc. (The Club) shall be to encourage the sport of yachting; to promote water safety and the science of seamanship and navigation; to promote the social welfare of and to provide entertainment and diversion for its members; and to hold title to real and personal property for the benefit of The Club. The Corporation is organized and shall be operated for one or more purposes which will permit the Corporation to qualify as an organization exempt from Federal income taxation pursuant to Section 501(c)(7) of the Internal Revenue Code. The Corporation is organized for pleasure, recreation, and other nonprofitable purposes, substantially all of the activities of which are for such purposes and no part of the net earnings of which inures to the benefit of any Member.
