

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LIGHTHOUSE GALLERY, INC.



Pursuant to the provision of Section 617.1006 of the Florida Not-For-Profit Corporation Act, the undersigned not-for-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is LIGHTHOUSE GALLERY, INC. (the "Corporation").
- 2. The following amendment to the Articles of Incorporation was agreed to and adopted by the Board of Directors of the Corporation on the 26th day of October, 1999, in the manner prescribed by Section 617.1002 of the Florida Not- For- Profit Corporation Act:

ARTICLE I of the Articles of Incorporation of the Corporation is amended to read as follows:

- "1. NAME: The name of the corporation is LIGHTHOUSE CENTER FOR THE ARTS, INC., and its principal place of business is located at, and its mailing address is, 373 Tequesta Drive, Tequesta, Florida 33469."
- 3. Members are not entitled to vote on a proposed amendment to the Articles of Incorporation.
