**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
FLORIDA AVENUE CHURCH OF CHRIST OF PALM BAY, INC**

*Pursuant to the provisions of section 617.1001, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendments to its articles of incorporation.*

**FIRST:**

**ARTICLE NUMBER "I"** is amended as follows:

The name of this corporation shall be CHURCH OF CHRIST AT FLORIDA AVENUE, INC., and its address shall be 1281 Florida Avenue, Palm Bay, Florida 32905.

**ARTICLE NUMBER "III"** is amended as follows:

The qualification for membership shall be as set forth in the New Testament Scriptures and according to the current "By-Laws" of the corporation.

**ARTICLE NUMBER "V"** is amended as follows:

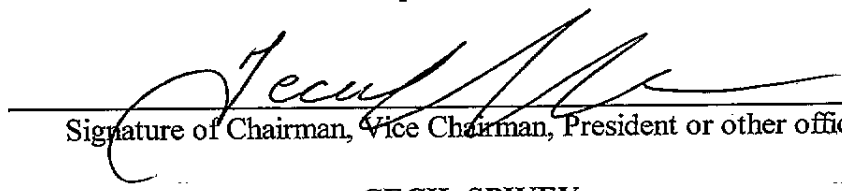
