FIRST AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF OCEAN TERRACE BEACH CLUB, INC.

Article II, Section 3 entitled "Members" and Section "9" entitled "Cabana" of the Amended and Restated Articles of Incorporation of Ocean Terrace Beach Club, Inc. are amended to read as follows (the language added is <u>underlined</u>; the language deleted is <u>struck out</u>):

3. <u>Members</u>. The members of the corporation shall be limited to owners as reflected in the Public Records of Palm Beach County, Florida, of the following parcels located in Palm Beach County, Florida:

Lots 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23 and 24 of the Plat of OCEAN TERRACE, recorded in the Plat Book 20, at Page 64, of the Public Records of Palm Beach County, Florida; and,

Lots 7 and 8 of the Plat of WALTON TRACT, recorded in in the Plat Book 18, at Page 8, of the Public Records of Palm Beach County, Florida.

("Membership Area" Lots", or individually "Lot").

- (a) A "Lot" is defined for the rest of these Articles of Incorporation as a portion of the Membership Area which (i) The Palm Beach County, Florida, Property Appraiser assigns a unique Parcel Control Number; and, (ii) Upon which pursuant to Florida Law and the Town of Palm Beach's regulations and ordinances a dwelling is allowed to be maintained.
- (b) Each Lot is entitled to: one membership regardless of the number of owners of the Lot; and, one vote per membership.
- (c) Each membership, regardless of the number of owners and regardless if a dwelling or other improvement exists or is constructed on the member's Lot, subject to the provisions of these Articles of Incorporation and the corporation's By-Laws, is allocated; one voting interest; and, the obligation to pay one equal share of the dues levied upon the members.
- (d) A Lot's membership shall be transferred to the Lot's grantee and terminated as to the Lot's grantor upon delivery to the corporation of the recorded instrument(s) upon which the grantee's a succeeding Lot owner's title is based, payment of dues and assessments including those not paid by prior owners of the Lot. being otherwise qualified as herein set forth, and as required in the corporation's By-Laws.

9. <u>Cabana</u>. Use of the corporation's cabana shall be pursuant to restrictions in the By-Laws and rules promulgated as provided in the By-Laws. Cabana use privileges may be extended to <u>a non-member non Lot owners</u>, but only on an ancillary basis to occupants of a Subdivision real property adjacent to a Lot owned <u>by a corporation Club</u> member, if that <u>corporation Club</u> member is in good standing and as provided in the <u>corporation's Club's By-Laws</u>.
